It is informed that online payment of Odd Semester fee for the year 2025-26 for all **Senior students of all programmes** is as follows and the fees should be remitted through online mode only using Debit cards/Credit cards/Net Banking and the remittance details are available in our Institute's Student Portal www.portal.ruraluniv.ac.in.

1. One month time for remittance of Odd semester fee from 21.07.2025 to 20.08.2025.
2. Late fee of Rs.200/- for next 10 days as I Extension from 21.08.2025 to 30.08.2025
3. Late fee of Rs.300/- for next 10 days as II Extension from 31.08.2025 to 09.09.2025
4. Late fee of Rs.1000/- for next 10 days as III Extension from 10.09.2025 to 19.09.2025
5. Final Late fee of Rs.5000/- along with odd semester fee for next 30 days from 20.09.2025 to 19.10.2025.

The defaulters name will be removed from the roll after the final extension and they will only be readmitted on remittance of Readmission fee of Rs.5000/- along with semester fee.

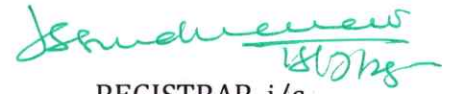
Further, it is informed that the students **who do not remit their semester fees within the due date will not be permitted to attend the End Semester Examinations.**
